RULES AND OCCUPANCY

OCCUPANCY IS LIMITED TO 15 PERSONS PER SANDUSKY FIRE REGULATIONS (APPLIES TO NON-PANDEMIC TIMES)

FOR SAFETY REASONS persons under the age of 15 are not permitted to use the Facility and Equipment unless accompanied by and under the supervision of an adult Owner or resident over 18 years of age. This room and facility are under video recording for the safety of those using the facility and to aid in the prosecution of crimes against this facility. For Safety reasons children are not permitted to play on/with equipment.

ATTIRE

- Proper exercise attire is required.
- Swimwear is prohibited.
- Appropriate athletic footwear must be worn in the fitness center.
- Bare feet are prohibited.

MISCELLANEOUS

- Removing equipment from the room is prohibited.
- No loud music or TV volume. Headphones must be worn.
- Food, candy and gum are prohibited.
- Only water is allowed. Alcohol, sodas, and juice drinks are prohibited.
- You must wipe off the dumbbell handles, seat pads, handles of all machines when you are done using them.
- In the winter, please remove wet shoes before entering the fitness room.

TV, LIGHTS, HEAT and AIR CONDITIONING

- Adjust heat/air to your comfort level and return it to 72 when leaving.
- Turn off TV when leaving.
- Turn off lights when leaving.

The Board of Directors for The Harbour Homeowners Association, Inc. reserves the right to suspend Facility and Equipment privileges for violation of these rules.

You are also on notice that the Facility and Equipment is unsupervised, and an accident or incident could occur that could result in property damage or injury, including death. You assume 100% of the risk of damage or injury arising from or related to the voluntary use of the Facility and Equipment.

The Board of Directors for The Harbour Homeowners Association, Inc. reserves the right to suspend Facility and Equipment privileges for violation of these rules.

Upon execution of this Liability Waiver and Release Agreement I will be given an access code. I acknowledge and agree that I am only allowed to share this access code with residents of my Living Unit and my guests and if I share the access code with anyone else my privileges to use the Facility and Equipment may be revoked.

I acknowledge and agree that I have carefully read this Liability Waiver and Release Agreement and the rules and regulations that apply to the Facility and Equipment, fully understand the contents thereof, understand that this is a release of liability and sign this Agreement as my own free act, with the intention of waiving any right that I may have to bring legal action or to assert any claim against the Association in connection with my access, use and/or participation in the Facility and Equipment, to be legally bound and to bind any person who could claim through myself, on and after the date set forth below.
